**Eligibility:** The **Chevy Rocks the Road with The Jonas Brothers Exclusive CD Release Sweepstakes** ("Sweepstakes") is open only to permanent legal residents of the forty-eight (48) contiguous states of the U.S. or the District of Columbia, who are physically located and residing therein (excluding Alaska, Hawaii), who are eighteen (18) years of age or older as of July 3, 2008.
